Descriptions of the following books were culled from publishers and reviewers.

Mark Achtemeier, *The Bible's Yes to Same Sex Marriage: An Evangelical's Change of Heart* (Westminster John Knox Press, Louisville), 2014.

Once a conservative, evangelical opponent of gay marriage, Achtemeier has become an bold activist. This book tells the story of his change of heart and mind and the role Scripture played in it.

\*\*James V. Brownson, *Bible, Gender, Sexuality: Reframing the Church's Debate on Same-Sex Relationships* (Wm. B. Eerdmans Pub. Co., Grand Rapids), 2013.

Brownson book offers a broad, cross-cultural sexual ethic from Scripture, placing current debates over homosexuality in a wider context and exploring why the Bible speaks as it does about same-sex relationships. Fairly presenting both sides of the debate, the book is a useful resource for those wishing to form an opinion this important issue.

\*\*David G. Myers and Letha Dawson Scanzoni, What God Has Joined Together: The Christian Case for Gay Marriage (Harper SanFrancisco), 2005.

This book is an effort to bridge the divide between people of faith who support marriage and those who support gay marriage. The authors draw on scientific research and biblical scholarship to debunk myths about sexual orientation, assess claims of sexual reorientation and explore what the Bible does and does not say about same-sex relationships.

Jack Rogers, *Jesus, the Bible, and Homosexuality* (Westminster John Knox Press, Louisville), 2009.

In this best selling book, Rogers argues for equal rights in both the church and society. He describes his own journey from opposition to support and outlines the church's history of using biblical passages to marginalized groups. In this more recent edition, he explains the recent progress made by major U.S. denominations toward full equality for same-sex persons.

\*\*William Stacy Johnson, A Time to Embrace: Same-Sex Relationships in Religion, Law, and Politics, 2nd edition, (Wm. B. Eerdmans Pub. Co., Grand Rapids), 2012.

In this book, the author analyzes the religious, legal and political debates about gay marriage, civil unions and committed gay couples. This recent edition also updates the change in laws related to civil unions and same-sex marriage since 2006.

Marvin M. Ellison, *Making Love Just: Sexual Ethics for Perplexing Times* (Augsburg Fortress), 2012.

Using a series of provocative questions, Ellison expands the discussion of marriage to engage readers in ethical considerations about sexuality. He affirms a more relational framework from which to consider the controversial, complex and conflicted issues of human sexuality.

Matthew Vines, God and the Gay Christian: The Biblical Case in Support of Same-Sex Relationships (Convergent Books), 2014.

Vines writes the story of his own attempt to navigate the relationships with his family, his hometown church and the broader church when he came out as a gay man. He offers a unique perspective for both an orthodox faith and sexual diversity through an examination of scripture and his own understanding of same-sex relationships.
